BMHA By-Laws/Rules and Regulations

BMHA By-Laws/ Rules and Regulations will be reviewed prior to the start of the 2023-24 season. Current reviews that have been completed will also be finalized.

Blackfalds Minor Hockey's current position of competitive/non-competitive stance has been challenged by the membership in the past season. A committee will be formed prior to the start of the season to determine the direction that best suits BMHA membership and players with the assistance of Hockey Alberta.

Blackfalds Minor Hockey Global Fundraising

- 50/50 Draws will continue for \$10,000.00 per draw for the 2023-2024 Season. The number of draws will be dependent on the length of our season.
- Required ticket sales will be based on the number of registered players
- 50/50 draws are expected to assist with operational costs and funding development programs to support your child's hockey experience.
- *New* BMHA registration fees will determine membership participation.



Financial Review

- Two BMHA members in good standing are required to review the year end financial statement.
- Registration fees are set to increase due to an expected
 Alberta Hockey and Hockey Canada membership fee increase.
- BMHA ice costs will increase this season however this will not be reflected on this year's registration.



2023-2024 Registration Fees

- 2023/24 Fees for Pups will increase with the addition of Alberta Hockey registration for insurance purposes. This will allow our pups team to travel and play games with other associations within their age group. An increase of \$55.00 Fundraising / \$55.00 Non Fundraising
- Increase for U7- U18 will be \$30.00 Fundraising / \$250.00 Non Fundraising +
 \$30.00 HA/HC fee membership increase
- The following payment options will be available:
 - Full Payment
 - 4 payment plan \$250.00 Deposit, plus 3 Payments (June, July August)
 - All payments must be in cash or credit
